### Terms & Conditions:

#### SDF Subsidies

\* Students applying for the part-time Diploma in Enterprise Development, Diploma in Tourism & Hospitality Management and Diploma in Strategic Wealth Management programmes may be entitled to SDF subsidies. The funding rates are as follows:  
 - Applicants who are below the age of 40 will receive a normal funding rate of S\$7/training hour.  
 - Applicants who are above the age of 40, and hold a qualification of Diploma and above, will receive a normal funding rate of S\$7/training hour.  
 - Applicants above the age of 40 with education qualifications of GCE 'A' Levels and below will receive an enhanced funding rate of S\$11/training hour.

\* ALL courses under ERCI are subject to prevailing GST rates

\* Installment payments are due on the stated month upon course commencement, and must be made no later than the 15th of each collection month.

### Value Added Premiums

- Course fees are inclusive of examination fees.  
 - Students will be given free Course Materials and Reference Books.  
 - Free Enrolment into the ERCI Total Success Programme (For all Bachelor and Masters students only)

### \*Rebates

Rebates will be given to students who meet the following criteria:  
 - Must be Singaporean or Singapore Permanent Residents  
 - Must pass all assignments and examinations within the given duration of the semester of the course.  
 A nett rebate amount (as stated above) will be given to students in the form of Rebate Vouchers, which can be utilised only in the final 2 installment payments of the course. Students who meet the above criteria will be able to utilise the vouchers in lieu of payment of their course fees.

### Exemptions:

Students who are granted exemptions will be required to pay an exemption fee of S\$50.00 for every module exempted, in addition to the modular fee (refer to Remodule Fees) for the programme applied for.

### CITREP Fee Endorsement

- Course and Certification Fees Subsidy: up to 80% of the nett payable course and examination fees capped at S\$3,000.00 per trainee.  
 - Certification Fees Only: up to 80% of the nett payable examination fees capped at S\$500 per trainee  
 - Absentee Payroll: The Sponsoring Organisations are eligible for Absentee Payroll support at S\$50 per trainee per day, when they sponsor their staff for Full-Time Training.  
 Full-Time Training refers to training courses conducted on weekdays, ie. Mondays to Fridays, between 8:30am and 6pm, with a minimum duration of 6 training hours.
